Checklist

Food and beverage processing and packaging businesses must be inspected and approved by the Ohio Department of Agriculture . This includes slaughterhouses, canneries and soft drink & frozen dessert plants, bakeries and cold storage warehouses. Contact the Ohio Department of Agriculture's Division of Food Safety at (614) 728-6250 for more information; or www.agri.ohio.gov . *Remember to check local government agencies. *
If you will process meat , your facilities must be inspected by the Ohio Department of Agriculture's Division of Meat Inspection . The Division of Meat Inspection can be reached at (614) 728-6260 .
