- [] Auctions must be conducted by licensed auctioneers. Auctioneers are licensed by the Ohio Department of Agriculture. Contact the Auctioneer Program at (614) 728-6240. - [] As a business owner, you should be aware of Ohio Consumer Laws and the Odometer Rollback and Disclosure Act.
