## **REQUIREMENTS & REGULATIONS**

[]	Any business that sells prescription drugs must be licensed by the <b>Ohio State Board of Pharmacy</b> . For more information, contact the Ohio State Board of Pharmacy at <b>(614) 466-4143</b> . Information is also on-line at <a href="http://pharmacy.ohio.gov">http://pharmacy.ohio.gov</a> . *Remember to check local government agencies*
[]	Ohio's Food, Drug, Cosmetic and Device law can be found in <b>Ohio Revised Code (ORC) Section 3715</b> . The <b>ORC</b> can be found in your local library or on-line at <a href="http://codes.ohio.gov/orc">http://codes.ohio.gov/orc</a> . *Remember to check local government agencies*
[]	Prescription drugs and some medical supplies/devices are NOT subject to sales tax.  *Remember to check local government agencies*
[]	Nonprescription drugs <b>ARE</b> subject to sales tax. *Remember to check local government agencies*
[]	If your business sells nonprescription drugs or makes retail sales, you must have a <b>VENDOR'S LICENSE</b> . Contact <b>YOUR COUNTY AUDITOR</b> or the <b>OHIO DEPARTMENT OF TAXATION</b> .
