### **REQUIREMENTS & REGULATIONS**

- [] There are no special state-level licenses required for watercraft excursions. \**Remember to check local government agencies*\*
- [] For watercraft registration and equipment requirements, contact the **Ohio Department of Natural Resources' (ODNR) Division of Watercraft** at **(877) 426-2837 or (614) 265-6480**. Information and forms are also available on-line at <u>http://www.dnr.state.oh.us/tabid/2062/Default.aspx</u>. *\*Remember to check local government agencies\**
- [] If you will provide a ferry service, contact the Court of Common Pleas in the county in which the body of water is located for licensing information. \**Remember to check local government agencies*\*
- [] If you will operate fishing charters on <u>Lake Erie</u>, contact the U.S. Coast Guard at (419) 418-6010 and the Division of Wildlife in Sandusky at (419) 625-8062 for licensing information or online at <u>http://watercraft.ohiodnr.gov/lakeerie</u>.
- [] Retail sales, equipment rental, beverages, and food eaten on the premises of your business are taxable. You must have a VENDOR'S LICENSE. Contact YOUR COUNTY AUDITOR or If you have questions about sales tax, contact the OHIO DEPARTMENT OF TAXATION at (888) 405-4039 for Business Tax Assistance; 888-405-4089 for Tax Registration; or (800) 282-1782 for the Forms Request Line. Information is also on-line at <a href="http://business.ohio.gov">http://tax.ohio.gov</a>. \*Remember to check local government agencies\*
- [] If you will serve food, through a **restaurant or concession stand**, contact **your local health department** for licensing and inspection information. \**Remember to check local government agencies*\*
- [] If you will sell **alcohol**, you must have the appropriate permit. Contact the **Ohio Department of** Liquor Control at (614) 644-2360 for more information. Information is also on-line at <u>http://www.com.ohio.gov/liqr/</u>. \**Remember to check local government agencies*\*
- [] If you will feature recorded **music**, you must have permission from the owner of the copyrighted material. You can do this by contacting **ASCAP** or **BMI**. For more information, contact **ASCAP** at (212) 621-6000 (www.ascap.com) or **BMI** at (212) 220-3000 at (www.bmi.com). \**Remember to check local government agencies*\*
