	Whether you are selling goods via the mail, telephone or Internet, you will need a TRANSIENT VENDOR LICENSE. Contact the OHIO DEPARTMENT OF TAXATION at (888) 405-4039 for Business Tax Assistance; 888-405-4089 for Tax Registration; or (800) 282-1782 for the Forms Request Line. 	Like any other business, mail merchants must comply with the Ohio Consumer's Sales Practices Act. The act prohibits unethical and devious sales practices.
